2. Introduction

David welcomed us to the meeting and confirmed that our association's charity status was confirmed on February 8th 2016 with the Hansa Class UK being given the Charity Number 1165467.

This meeting is a special and necessary meeting in our progress towards establishing the new constitution.

Marcus and David have worked on a presentation of the new constitution for us, which they will present at this meeting.

3. Presentation of the proposed new constitution.

Marcus and David talked us through the following PowerPoint presentation:

3.1 Hansa Class UK - CIO

Charity Status was confirmed on February 8th 2016 with the Hansa Class UK being given the Charity Number 1165467

3.2 Charitable Incorporated Organisation (CIO)

The CIO is a new legal form designed specifically for charities. The structure aims to provide charities with some of the benefits of being a company, without the additional reporting and legal requirements which incorporated charities may be subject to.

A CIO:

- Is an incorporated form of a charity and not a company.
- Is only created once it is registered by the Charity Commission, but does not need to register separately with Companies House.
- Is required to provide a single annual report and annual return to the Commission, with no requirement to produce a director's report or an annual return to Companies House.
- Can register and file information free of charge
- Will need to register amendments to our constitution with the Commission before they are implemented, and will require prior consent for some amendments; Is covered by insolvency law.
- Can enter into contracts in its own right, and its trustees will have limited or no liability for debts.

3.3 Current Position

- We have a first constitution duly approved by the charity commission.
- We have appointed the initial Trustees as required by the charity commission application process.
- Initial Trustees are (Chair, Vice Chair, Secretary and Treasurer at time of application)

- We submitted a revision of the initial constitution to meet the charity commission requirements. This
 has been approved.
- There is a requirement to have the first AGM of the Hansa Class UK within 18 Months of formation.
- There is now a proposed slightly revised constitution as a draft for consultation.

3.4 How we achieve our objects

- The development and promotion of inclusive learn to race sessions providing education, training
 and support for potential and existing sailors. Offering training courses to volunteers in race
 coaching and race management and to allow the development of Hansa class racing around the
 country.
- Running a national racing programme at three levels Blue Fleet, Travelers and Grand Prix offering inclusive racing for everyone. That is accessible to everyone.
- Provide coaching and teaching sessions for aspiring sailors. Running coaching clinics for experienced sailors in preparation for major events and competition.
- Encourage disability awareness in the field of sailing, racing and volunteers support.
- Provide loan boats equipped for inclusive sailing to promote the opportunities for all disabilities to sail and race.
- To assist in the health and welfare of participants, developing personal and team skills, confidence and physical wellbeing.
- Visiting sites with potential for inclusive sailing and racing to develop interest, support local development and participation while mapping the progress of new sailors.
- Promotion of the opportunities to independently sail and race with any disability through marketing and promotion and signposting interested individuals to our programmes.

5. Questions and Answers:

• 5.1 **Question** = Why a CIO – **Answer** = See 3.2 above plus it gives Trustees the protection that, providing the trustee works within the constitution and other organisational rules and guidance, the organisation is liable at law not the individual.

- 5.2 **Question =** Are there any powers that the trustees cannot delegate to others if so what are they. **Answer =** Yes. The Board of Trustees cannot delegate 1. The Annual Accounts. 2. The Annual Report and 3. Health and Safety
- 5.3 **Question** = How will the new membership rules be manged at AGM. **Answer** = We will have a list of Full Members as of the closing date of nominations for office. These will be the Members that will be eligible to vote
- 5.4 **Question** = Why should I become a Member. **Answer** = By becoming a member you are able to vote, you can sail in any of our UK events, you can also sail in any of the International Hansa Class events and your vote gives you a voice within the Association with which you can influence and support all aspects of our activities and developments.

6. Any other business

- **6.1** 2016 AGM Due to attendance problems with the planned date it was agreed that the date should be changed. Therefore the 2016 AGM will now be held at the RYA Multiclass event on Saturday 6th August at 7pm.
- **6.2** Pat asked for clarification on the format and prizes expected for the International Hansa Nord Cup and Hansa GP that will be incorporated into the 2016 RYA Multi-Class at Rutland on 5th to 7th August 2016.

Marcus told him that both will be sailed on the same course, separate from the other Multi-Class classes and confirmed that all details had been sent to Ralph. Ron confirmed that the GP would have the usual 1st, 2nd and 3rd place prizes for each class and that they are provided by the host club (Rutland Sailability) but to check if RYA were providing them as the event is part of their Multi-Class. Marcus said that there were to be no separate prizes for the International Nord Cup. Marcus said that there is to be a "Blue Fleet" event on the Friday of the Multi-Class.
